Policies and regulations of Harvest Gathering Events and website

Section 1: Waiver

- 1.0 The Harvest Gathering is a volunteer run event. It is not put on by an organization or individual. All participants are responsible for themselves & their children and their own well being; including personnel safety.
- 1.1 Personal set-up, day to day logistics and grounds clean-up are individual responsibilities and you are part of a community that has focused crews that you will be asked to volunteer for. It is an expectation that you volunteer for a work crew and help with tasks such as: cutting firewood, maintaining wash stations, camp clean up, outhouse clean up, etc.
- 1.2 In all workshops, demonstrations, and excursions conducted by the Harvest Gathering organizers, landowners and associates; reasonable care is taken to prevent serious injuries and to minimize accidents.
- 1.3 The Participants states that he/she is fully aware that survival, tracking, awareness training, and all other workshops and activities, even when care is taken, may be dangerous, and the Participant hereby agrees to accept full responsibility and assume all risks, including those caused by acts of God, injury, death, incompetence, and/or loss to his/her person and/or property knowingly and voluntarily.
- 1.4 The Participants agree to obey the rules and regulations set forth by organizers, landowners and associates, put into effect to minimize these risks, and outlined below. Further regulation may be enacted and enforced during the event by event organizers in the interest of public safety and enjoyment. All participants must follow these rules and instructions at all times, or be removed from the property by the organizers without refund or rebuttal.
- 1.5 The Participant knowingly, voluntarily, and irrevocably waives any and all past, present, and/or future injuries, death, or loss, including those caused by acts of God, received while participating in activities conducted at the Harvest Gathering by any of the organizers, landowners and associates, as a participant, spectator, and/or visitor, or in any other manner or form, taking part in the exercises, practices, excursions, and/or demonstrations of said survival, tracking, awareness training.
- 1.6 The participant certifies that he/she is physically capable to participate in the said survival, tracking, awareness program despite the rigors and dangers inherent in such an undertaking. The Participant accepts all responsibility for injury, death, and/or loss to his/her person and/or property, including those caused by acts of God, for the rigors and dangers inherent in the undertaking.

Section 2: Site regulations

- 2.0 All those in attendance must purchase a wristband indicating proof of admission, and display it at all times while at the event. Not only does this wristband serve as proof of purchase, but also acceptance of all sections of this document, as indicated in the enrollment form.
- 2.1 The event organizers, and active Duty Officer have the final say in all matters of rules, and safety, and can remove any persons found not to be in compliance, without refund.
- 2.2 All laws and legislations relevant to the jurisdiction where the event is taking place are to be followed without evasion or omission.
- 2.3 Alcohol should only be consumed in moderation as this is a family event, and mental faculties are important for wilderness safety. Anyone found to be intoxicated beyond a reasonable manner can be removed by either taxi, or emergency services, at the participant's expense.
- 2.4 Bringing dogs or other pets to the gathering is allowed, but discouraged. Dogs must be leashed at all times, and must neither endanger, nor diminish the enjoyment of other participants in the event. Event organizers or the active Duty Officer may request an animal be removed from the General area, and placed in a secure location where both the animal and other participants are safe. Owners are responsible for their pets, including the removal of all waste products from the general areas of the Gathering.
- 2.5 Due to the amount of people attending the event, there is to be no usage, display, or discharge of firearms, except in serious cases of emergency, <u>and</u> as approved by the active Duty Officer.
- 2.6 All actions and behaviour should fall within the reasonable intention of allowing all participants to fully enjoy the experience of the event without feelings of hardship, bias, abuse, profiling, or discrimination.
- 2.7 All recyclables, and refuse materials brought onto the event site must be removed by the individual. Those caught littering or dumping of materials may be asked to leave.

Section 3: Personal Information Protection Policy
